

WILSON SCHOOL DISTRICT VOLUNTEER AFFIDAVIT BY

I am the person identified above. It is my desire to perform volunteer services for the Wilson School District (the "School"). In that capacity, I will perform various non-teaching duties as assigned but understand that in no case will I be paid for performing such tasks.

In the course of my volunteer duties for the School, it is expected that I will have "direct volunteer contact with children," meaning that as part of my volunteer duties for the School I will have some level of regular and repeated care, supervision, guidance or control of the School students.

Because of that direct volunteer contact with children, pursuant to the Child Protective Services Law I have submitted with this form a criminal background report from the Pennsylvania State Police and a Child Abuse History report from the Statewide Child Abuse database. **Additionally**, I have either submitted an FBI criminal record report, or marked below to swear or affirm that I have continuously resided in the Commonwealth of Pennsylvania for the last ten years.

Even if not reflected on the attached reports, I also swear or affirm that:

- **Within the last five (5) years**, I have NEITHER been listed in the Statewide abuse database as a perpetrator of a founded case of abuse NOR committed a felony under the Pennsylvania Drug Device and Cosmetic Act (or similar act under the laws of another jurisdiction) for which I was later convicted.
- **I have never** been convicted of any of the Pennsylvania offenses or similar offenses from any other jurisdiction that are listed on the reverse of this form. (Please see the list of offenses on the reverse).

ADDITIONAL ACKNOWLEDGEMENTS RELATING TO THE TERMS OF VOLUNTEERING

I understand that I must be dismissed if I have been or am later named as a perpetrator of a founded report of child abuse or named as the individual responsible for injury or abuse in a founded report of child abuse.

I understand that I must be dismissed if I have been or am later convicted of any of the crimes listed above.

I understand that I have a duty to report in writing any new arrest or conviction for any of the above listed offenses or any new allegation of abuse within 72 hours of the arrest, conviction or notice of the allegation and a failure to give such a timely report will make me ineligible to volunteer even if I am later exonerated related to the underlying allegations.

I have been provided with a copy of and have read the Wilson School District policy on Volunteers and agree to comply with that policy.

I understand that as a Volunteer I am **not** an employee and I will not receive any compensation of any type for the work performed.

I understand that I am **not** entitled to workers’ compensation or group medical benefits or any other benefits from the School while acting as a volunteer.

I understand that I may be terminated at any time by the School as a volunteer without any formal proceedings, without “just cause” or any cause at all and that I serve at the sole discretion of the School.
